Definitions:

- COTS: Commodities/Parts generally purchased off a catalog/website such as McMaster Carr, supplies from Home Depot, non-military EEE or non-Military fasteners, hardware.
- 2. Built to Print: Commodities/Parts such as unpopulated PC Boards built to print; circuit card assembly built to drawings, mechanical parts built and finished to a drawing. Parts with customer flow down requirements. Acceptance/Characteristics defined on drawing and/or Radiance PO. May include special handling & packaging requirements. May have ITAR implications.
- 3. Components: Commodities/Parts such as EEE parts, actives, passives, and mil spec parts industrial grade parts, age sensitive parts with shelf life and or moisture sensitive parts. Need for certification and possibly flow down and/or traceability requirements essential for conformity. Mil specs may have ITAR implications and/or need for counterfeit avoidance clause on Purchase Order.
- Counterfeit: A part is a copy or substitute without legal right or authority to do so or one whose material, performance or characteristics are misrepresented.
- 5. Services: A contract (either subcontract or purchase order) issued for the time and effort of a vendor/contractor whose primary purpose is to perform an identifiable task rather than to furnish an end item of supply. A statement of work and a list of deliverables will be required to place any kind of award for services.
- 6. Suspect Counterfeit: A part in which there is an indication that it may have been misrepresented by the supplier or manufacturer and may meet the definition of a counterfeit part.
- 7. OCM: Original component manufacturer
- 8. OEM: Original equipment manufacturer
- Franchise Distributor: A distributor with which the OCM or OEM has a contractual agreement to buy, stock, re-package, sell, and/or distribute its product lines.
- 10. Independent Distributor (Broker): A distributor that purchases parts with the intention to sell or redistribute them.
